Newsletter 8th January 2021

Dear Parents,

I do wish you all a Happy New Year even though it is not the start we wanted unfortunately. That said I am hopeful for the future and looking forward to when we can all be back together in school.

We began the week believing our children would be back in school on Tuesday. We found out we would be closing the same time as you, when Mr Johnson announced it at 8pm on Monday evening. Since then we have endeavoured to put things in place as quickly as possible and appreciate your positive comments about how the school has communicated and operated this week.

Our two main priorities last Tuesday were:

- Key Workers / Vulnerable provision in school-ascertaining the need from families and ensuring we have the staff and updated risk assessment for this to begin within 24 hours on the Wednesday
- Remote learning to start within 24 hours on the Wednesday- we sent a letter to all families explaining how we were going to address this and to please bear with us as we adapt and improve this over the next few days.

We are still in the early days with our remote learning system and this has been reviewed and adapted since the summer. Thank you for bearing with us as we set this up and embed over the next few days. You will no doubt know of provision in other schools - we have consulted with colleagues locally and are aware of how we are all leading our teaching and learning during this lockdown. Here at Goostrey, we have listened to families and endeavoured to create a working system that is suitable for families with different home technologies and working commitments. No one system suits everyone, we do recognise this and are aiming to do the 'best fit' for everyone.

We have tried to create a balance of sessions for the children, that can be accessible at anytime to support families with varying time pressures. After much discussion we believe this is more beneficial than just live lessons as a prescriptive time.

However we do believe that regular contact with the class teacher is vital for you and for us. Your child will have daily contact with their teacher in different ways.

- through videos showing Goostrey teachers delivering the lesson
- audio attached to work (with the teacher's voice directing the learning) ٠
- opportunity for a daily drop-in Google Meet, from next Monday (face to face with the teacher, albeit through a • screen)
- regular support via the learning platform through messages from school to home and vice versa •
- videos from trusted external providers such as, White Rose, Love Music Trust and Oak National Academy (these will be selected to support the work of our own school curriculum)
- emails between school and home

We will adapt and change the remote learning system as we feel appropriate and please rest assured that we will always aim to do our very best for you in this difficult times.

I am very proud of all of the staff for their resilience, dedication and adaptability. I know one system does not suit all and I am very aware of how stressful this situation is for all staff and families— we all want the same thing the children back in school safe, happy and learning.

Thank you for your continued support.

Income Related Free School Meals

During these uncertain times it is even more important that families register their eligibility for Income Related Free School Meals, even if their child receives the UIFSMs in KS1. At present registering eligibility allows for the continuing provision of food (hopefully vouchers again) when pupils are not in school. There is also provision for these families to get assistance with data provision from many mobile phone providers, to assist in accessing remote learning.

Registering eligibility is also important to the funding school receives, generating a specific fund called Pupil Premium, of £1320 per eligible pupil. This funding is used to support those pupils with their education. A full report on Pupil Premium use can be found on our website.

Please be assured that staff do not receive information about individual circumstances. We are simply notified of eligibility and start and end dates. Children cannot be identified in any way to other pupils. If you have any queries regarding this information please speak to our School Business Manager, Mrs Schurer-Lewis.

Please register eligibility for IRFSM if you meet the criteria below:

Income Support

- Income based Jobseeker's Allowance
- Income related Employment Support Allowance
- Support under Part VI of the Immigration and Asylum Act 1999
- The guaranteed element of State Pension Credit
- Child Tax Credit as long as you have a yearly household income of less than

£16,190 (as assessed by HM Revenue and Customs) and do not get Working Tax Credit

• Working Tax Credit run-on (paid for 4 weeks after you stop qualifying for Working Tax Credit)

• Universal Credit—household income must be less than £7,400 a year (after tax and not including any benefits you get)

Change in Isolation Date for Close Contacts

The <u>Stay at home: guidance for households with possible or confirmed coronavirus (COVID-19) in-</u> <u>fection</u> has changed from today meaning that self-isolation for contacts of people with confirmed coronavirus will be shortened from 14 to 10 days.

Key summary points of the new isolation guidance include:

As of **Monday 14th December 2020**, the isolation period will reduce to 10 days.

Anyone asked to isolate by an NHS Test and Trace staff member or on the advice of Public Health/ Public Health England (including our COVID Helpline) before Monday 14th December 2020 will only need to isolate for 10 days. For example, anyone told to isolate until 16th December 2020, will be able to stop isolating on the 14th December 2020. If you were told to isolate until the Sunday 13th December 2020, you must continue with the full isolation period until Sunday 13th December 2020.

The NHS T&T App will not update with the new isolation periods until **Thursday 17th December 2020**. Anyone told to isolate by the App from now until Thursday 17th December 2020 can stop isolating when the countdown says "3 days remain". After Thursday 17th December 2020, everyone who needs to isolate for the full period will be notified by the App.

4. Isolation periods will take the day contact occurred as Day 0 of the isolation period, so contacts must remain in isolation until Day 11. For example, contact on 11th December 2020 = Day 0; last day of self-isolation is 21st December 2020 = Day 10; able to resume normal activities on 22nd December 2020 = Day 11.
